II. Intended Learning Outcomes of the Program (ILOs)

A. <u>Knowledge and Understanding</u>: By the end of the program the candidate should be able to:

- 1) Define the health needs and problems according to the human life cycle.
- 2) Describe the health care system as well as the medico legal legislations in Egypt.
- **3)** Recognize the health promotion and preventive measures at the level of individuals, families and communities.
- 4) Determine the epidemiological needs of the local and regional communities.
- **5)** Explain the etiology, clinical manifestations, differential diagnoses, prevention and management of the common, important and emergency medical conditions in Egypt according to the best available evidence.
- 6) Identify the uses, effects, side effects and drug interactions of drugs used in primary health care level (in pediatrics, adults, geriatrics, pregnant, lactating females and patients with liver or kidney diseases).
- 7) Report the principles of medical ethics.
- 8) Express the different types of research methodology, and medical statistics.

- 1) Integrate the information gathered from medical records, history, clinical examination and investigations to reach a proper diagnosis or differential diagnosis.
- 2) Design community focus research.
- 3) Critically appraise research articles.
- 4) Apply administrative and quality management skills in conducting cost-effective community services.

C. <u>Professional and Practical Skills</u>: By the end of the program the candidate should be able to:

- 1) Provide appropriate counseling in health and disease with patients and their families.
- 2) Develop a holistic patient-centered management plan based on the national/international guidelines.
- 3) Use the different models for behavioral modification for life style modification.
- 4) Master routine procedures and skills needed in family practice.
- 5) Initiate management of emergency cases (in a timely manner) and perform proper referral.
- 6) Perform basic life support measures when indicated.
- 7) Individualize drug use in a cost effective manner.
- 8) Utilize medical records to insure appropriateness of continuity of care.
- 9) Apply a coordinated referral system.

Practical training program (3rd phase, advanced training):

According to the faculty of Medicine, Cairo University Bylaws for postgraduate programs (July 2009), the duration of the advanced practical training is 24 months. All the students should complete the advanced training program for these two years in the Family Medicine Department in order to acquire the needed credit points.

Medical Doctorate Thesis:

All MD degree students should prepare a thesis. The research and ethical committee must approve the protocol of research. The thesis must include review of literature and a research. The thesis is supervised by one or more senior staff members and may include personnel from other specialties according to the nature of the research. The thesis should be evaluated and approved by a committee of three professors including one of the supervisors and an external professor.

Scientific Activities:

The candidates should participate in the scientific activities of the department such as:

- Seminars
- Journal clubs
- Scientific meetings
- Workshops
- Conferences
- Thesis discussions

Each activity is allocated a number of points. The log book is revised prior to the permission for MD exam entry to ensure the completion of the recommended points.

VI. Regulations for Progression and Program Completion

After collecting the required credit points for the related courses of Family Medicine syllabus, the advanced practical training, the scientific activities and ultimately the Thesis, the candidate will be eligible to sit for the final examination. In case of failure of the candidate to pass the examination, he/she may resubmit for the next examination. The candidate will receive the MD degree after passing this final examination. MD degree should be obtained within a maximum of six years after the registration date.

VII. Assessment

A: Assessment Tools

• Supervision and Monitoring of Training Program

According to the Faculty of Medicine, Cairo University Bylaws for practical Training Programs, the supervisors carry continuous assessment during the program. A practical training program logbook will be kept for each candidate to document all his/her practical activities as well as his/her participation in different scientific activities. The head of the department should allow the candidates to undergo the final examination when they complete their training program and collect the needed credit points.

• Formal Assessment

According to the Faculty of Medicine, Cairo University Bylaws for postgraduate Programs (July 2009). Students should be assessed at the end of the program.

- <u>**Compulsory courses:**</u> Family medicine: distributed in three written exam papers, three hours each (Problem-solving questions, essay questions, MCQs, EMQs and three cases)+ practical and oral exams.
- <u>Elective courses:</u> Geriatric Health Care, Children And Adolescent Health Care, Women Health Care and Mental Health Care (choose one courses): distributed in one written exam paper for three hours (problem-solving questions, essay questions, MCQs and EMQs) + practical and oral exams.

B: Assessment Schedule:

Written examination will be held in four days (Three hours each) include short and long assay questions, and MCQ (include problem solving). This will be followed by the practical and oral examinations in separate days.

The written exam will be held in May/ November (four days) Day one: Family medicine (2 paper 3 hours each written exam) Day two: Family medicine one commentary 3 cases The practical exams will be held in two days. The oral exams will be held in two days.
